Love the Lawn Sweepstakes

Official Rules

1. NO PURCHASE OR OBLIGATION NECESSARY TO ENTER OR WIN.

2. **ELIGIBILITY** | The **Credit Union 1 Love the Lawn Sweepstakes** (“**Sweepstakes**”) is open only to legal residents of Illinois, Indiana, and Wisconsin who are eighteen (18) years of age or older as of May 20, 2024. Void in Puerto Rico and where prohibited. Employees of Credit Union 1 (“**CU1**”), and each of their officers, owners, directors, agents, representatives, and employees (collectively, “**CU1 Entities**”), Credit Union 1 (“**Sponsor**”, **Administrator**”, and “**Judge**”), prize suppliers, and advertising and promotion agencies, Live Nation Worldwide, Inc. (“**Live Nation**”), Instagram, Facebook, or X, and each of their respective agents, representatives, officers, directors, shareholders, and employees (collectively, “**Releasees**”), and each of their immediate family members (spouse or partner, parents, children, siblings, and their respective spouses or partners, regardless of where they live) and individuals living in the same households of each of these individuals, whether related or not, are not eligible to enter or win. Sweepstakes is subject to all applicable federal, state, and local laws. The Sweepstakes is governed by U.S. law.

3. **SWEEPSTAKES TIMING/DESCRIPTION** | Begins at 12:00:00 PM Central Time (“**CT**”) on May 20, 2024, and ends at 11:59:59 PM CT on August 16, 2024 (“**Promotion Period**”). There will be two hundred fifty (250) winners (“**Winner**”) total that will each be awarded (2) lawn seat tickets, selected in a random drawing that will occur weekly during the Promotion Period from among all eligible entries received. The initial weekly drawing will occur on May 27, 2024 with the final weekly drawing occurring on August 19, 2024.

4. **TO ENTER** | This sweepstakes is being administered by Credit Union 1. Entrants can earn one (1) entry into the random drawing by:

- (a) Following the Credit Union 1 Instagram page (@cu1forall) OR following the Credit Union 1 X page (@MyCreditUnion1) OR liking Credit Union 1’s Facebook page (@MyCreditUnion1)

AND

- (b) **SUBMITTING AN ENTRY FORM ONLINE** at www.creditunion1.org/love-the-lawn **WITHOUT PURCHASE OR OBLIGATION:**

Complete online entry form with first and last name, street address, city, state, ZIP code, and daytime and evening telephone numbers (including area code), and valid email address. Entries must be timestamped and received starting on May 20, 2024 and ending at 11:59:59 PM CT on August 16, 2024, in order to be included in the random drawing. One (1) entry per entrant is allowed. Entries that are incomplete, inaccurate, non-compliant with the Official Rules, or by any means subvert the entry process are void. Entries become the property of the Sponsor and will not be acknowledged or

returned. Proof of submission does not constitute proof of delivery.

5. DETERMINATION OF WINNER/WINNER NOTIFICATION | Two hundred fifty (250) potential Winners will be selected by the Judge during the Promotion period. During the Promotion Period the potential winners will be selected by the Judge via random weekly drawings. The initial weekly drawing will occur on May 27, 2024 with the final drawing occurring on August 19, 2024. The potential winners will be determined from among all eligible entries received. The Judge's decisions are final and binding on matters relating to this Sweepstakes. Each potential winner will be notified by telephone and/or email within five (5) days of the drawing date and will be required to verify their eligibility by timely digitally completing and securely signing an Affidavit of Eligibility and Release and a Publicity Waiver and Release where legal (collectively, the "**Declaration**"), and submitting the Declaration to Administrator via DocuSign within forty-eight (48) hours of notification. Non-compliance with this time frame and/or with these Official Rules, Sponsor's inability to contact potential winner within a reasonable time period, as determined by Sponsor, and/or prize or prize notification returned as undeliverable will result in such potential winner's disqualification and the prize may be awarded to a potential alternate winner, at Sponsor's discretion.

6. ODDS | The actual odds of winning depend upon the total number of eligible entries received during the Promotion Period.

7. PRIZE AND APPROXIMATE RETAIL VALUE ("ARV")

Two hundred fifty (250) winners will each receive two (2) lawn tickets to a concert of their choice (based on availability) during the 2024 concert season, at Credit Union 1 Amphitheatre in Tinley Park, IL. Parking, travel, and accommodations not included and are the sole responsibility of winner and guest. Ticket delivery method is at sole discretion of Live Nation which will be either sent to winner by mail, email, mobile ticketing or placed at venue Will Call the day of Concert under the winner's name. Winner must be present to pick up tickets and a valid photo ID will be required if tickets are placed at Will Call. Approximate Retail Value of each prize is: One Hundred Twenty Dollars and No Cents (\$120.00).

Prize Restrictions | If winner is at least 18 but still considered a minor in his/her state or place of residence, his/her parent or legal guardian will be required to accompany minor winner to the concert. A minor may accompany winner as a guest only if the winner is the minor's parent or legal guardian. Minors must be accompanied at all times during all prize-related events by minor's parent or legal guardian. If winner and guest are unable to attend the concert on the date specified by Sponsor for any reason, including not being able to comply with any public or private travel restrictions, Prize will be forfeited. Sponsor reserves the right to change dates for Prize. Prize is subject to Credit Union 1 Amphitheatre scheduling, and other conditions and restrictions including public health restrictions. Sponsor is not responsible for any fees or additional charges resulting from any changes to itinerary or accommodations made by prize winner and/or his/her guest. **Sponsor will not replace any lost or stolen tickets, travel vouchers or similar items once they are in winner's possession or in the possession of a guest.** Prize conditions may be added or modified by companies providing those portions of the prize. The prize restrictions/conditions stated herein are not all-inclusive and may be subject to additional restrictions/conditions. Tickets are subject to certain terms and conditions as specified by CU1 and Live Nation. Winner and guest must be at least eighteen (18) years of age and must abide by all venue and event policies, to include but not limited to, showing a valid photo ID at venue for age verification

and/or identification purposes if requested. Live Nation reserves the right to revoke full or partial prize from any winner or winner's guest who it and/or venue personnel deem may, in their sole discretion, be intoxicated, be a safety risk, have violated any venue policy or law, and/or may bring Live Nation into disrepute. Winner understands that there are inherent risks involved in being in public spaces and that these risks may be present before, during and after the Concert. Resale of tickets is prohibited. By claiming tickets, you agree to Live Nation's [Terms of Use](#) and to abide by the health and safety measures in effect at the time of your concert, which may include, but not be limited to, wearing masks, providing proof of vaccination status and/or providing proof of negative COVID-19 status. Failure to do so may result in forfeiture of such portion(s) of prize. Sponsor reserves the right to remove or deny entry to the winner and any guest who does not comply with any health restrictions imposed by any government, Sponsor, or any venue, stadium or event, engage in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten, or harass any other person at the game. Winner and guest should also review any advisories or restrictions that may be in place for travel to Illinois. Should the Event be cancelled, you will be notified as soon as reasonably possible.

No substitution, cash equivalent, or transfer of any prize permitted except at the sole discretion of the Sponsor and Live Nation, who reserves the right to substitute a prize (or portion thereof) with one of equal or greater value, except as otherwise explicitly provided herein. Any and all other costs and expenses associated with prize acceptance and use not specifically stated within these Official Rules as being provided, are the sole responsibility of the Winner, including, without limitation, all federal, state, and local taxes, and additional features or accessories. Prize details are at Sponsor's sole discretion. If any portion of prize is unavailable for any reason, including but not limited to, cancellation, delays, a public health crisis, or any federal, state, and/or local government regulations, orders, or guidelines, Sponsor reserves the right to substitute the prize or portion thereof with one of equal or greater value and no other additional compensation or substitution will be provided.

8. CONDITIONS OF PARTICIPATION | By entering, entrants agree to be bound by these Official Rules, including all eligibility requirements and the decisions of the Sponsor/Judge, which are final and binding. By accepting prize, Winner consents to the use of his/her/their name, image, likeness, photograph, voice, and biographical material for advertising, publicity, and promotional purposes by Releasees, in any and all media now or hereafter devised, including but not limited to, any online announcements, worldwide in perpetuity, without additional compensation, notification, or permission, except where prohibited by law. Entrants agree to release, discharge, indemnify, and hold harmless Releasees from any claims, actions, injury, loss, or damage of any kind, including but not limited to, personal injury or death, resulting, directly or indirectly, in whole or in part, from participating in this Sweepstakes or from the acceptance, possession, or use or misuse of the prize (including any travel/activity related thereto). This release and limitation of liability is a comprehensive and applies to all damages of any kind, including (without limitation) compensatory, direct, indirect, punitive, or consequential damages; loss of data, income or profit; loss or damage to property; and claims of third parties. Entrants agree that Releasees have not made nor are in any manner responsible or liable for any warranty, representation, or guarantee, statutory, express or implied (including but not limited to, the implied warranties of merchantability, title, and fitness for a particular purpose), in fact or in law, relative to the Sweepstakes. Winner fully understands that (a) the novel coronavirus SARS-CoV-2 and any resulting disease (together with any mutation, adaptation or variation thereof, "**COVID-19**") is extremely contagious and there is an inherent risk of exposure to COVID-19 in any place where people are or have been present, including

without limitation any UIC or Sponsor event; (b) no precautions, including the protocols that will be implemented from time to time by Releasees, the U.S. Department of Health and Human Services (collectively, the “**Protocols**”), can eliminate the risk of exposure to COVID-19; (c) while people of all ages and health conditions have been adversely affected by COVID-19, certain people have been identified by public health authorities as having greater risk based on age and/or underlying medical conditions; and (d) exposure to COVID-19 can result in being subject to quarantine requirements, illness, disability, other short-term and long-term health effects, and/or death, regardless of age or health condition.

9. **GENERAL** | Sponsor will collect information from the entrants for the purpose of the prize drawing and to notify potential winners. Sponsor is authorized by entrant to share this information with Live Nation and as necessary for the administration of the Sweepstakes. Sponsor may attempt to contact entrant, to market information on Sponsor’s products and promotions. Entrant by entering the Sweepstakes is providing its consent for Sponsor to contact entrant to market Sponsor’s products and promotions. Entrant agrees that methods of contact may include the use of pre-recorded or artificial voice messages, and/or use of an automatic dialing device, via text, e-mail or any other means of communication. Entrant may withdraw consent at any time by any reasonable means that provides Sponsor with reasonable notice. By entrant providing a wireless telephone number, entrant represents and agrees entrant is the wireless subscriber or customary user with respect to the wireless telephone number provided and has the authority to give this consent. Entrant agrees to notify Sponsor of any change to the wireless telephone number which entrant has provided to Sponsor. If entrant provides an email address, entrant provides authorization to Sponsor to send entrant email messages using an automated emailing system for commercial or transactional purposes. Releasees are not responsible for lost, late, illegible, misdirected, inaccurate, incomplete, undelivered, damaged, delayed, garbled, postage-due, or stolen mail, entries, and transactions; for transactions that are lost, misdirected, or fail to enter into the processing system, or are processed, reported, or transmitted late or incorrectly; or for any other errors or problems of any kind, whether typographical, printing, mechanical, human, electronic, or otherwise, relating to or in connection with the Sweepstakes, including, without limitation, any error or problem that may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of the prize or in any Sweepstakes-related materials. Entry materials that have been tampered with or altered are void. Sponsor reserves the right, in its sole discretion, to cancel or suspend part or all of this Sweepstakes at any time without notice and for any reason including but not limited to, if in the Judge’s opinion there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the Sweepstakes; if virus, bugs, non-authorized human intervention or other causes corrupt or impair the administration, security, fairness, or integrity and proper play of the Sweepstakes; a public health crisis; or any government regulations, orders, or Protocols affect the Sweepstakes. In the event of cancellation, Sponsor may terminate the Sweepstakes entirely or void any entries it suspects do not comply with the Official Rules and, at its discretion, if terminated, award prize in a random drawing from among all non-suspect, eligible entries received up to the date of cancellation. **Caution: Any attempt by an entrant or any other individual to damage or undermine the legitimate operation of the Sweepstakes may be in violation of criminal and civil laws and, should such an attempt be made, the Sponsor reserves the right to seek any and all remedies available from any such person to the fullest extent permitted by law, including criminal prosecution.** Sponsor’s failure to enforce any term of these Official Rules shall not constitute a waiver of

that or any other provision. Sponsor reserves the right to disqualify entrants who violate these Official Rules or interfere with this Sweepstakes in any manner.

10. TAXES | The value of the prize will be taxable to the Winner as income. Sponsor will issue the Winner an IRS FORM1099-MISC for the value of the prize selected if it is valued at \$600 or more. All federal, state and local taxes and any other costs and expenses associated with the acceptance and/or use of the prize not specifically provided for in these Official Rules are solely the responsibility of the Winner. Winner is solely responsible for reporting and paying any and all applicable taxes.

11. DISPUTES | Except where prohibited, all issues/questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Illinois, without giving effect to any choice of law or conflict of law rules (whether of the State of Illinois or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the State of Illinois. Jurisdiction and venue shall be solely within the State of Illinois.

12. FORCE MAJEURE | In the event an insufficient number of eligible entries are received and/or Sponsor is prevented from awarding the prize or continuing with this Sweepstakes as contemplated herein, or the prize due to any event beyond Sponsor's control, including but not limited to fire, flood, natural or man-made epidemic of health or other means, earthquake, explosion, labor dispute, lockout, or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal, state or local government law, order, regulation, or Protocol, public health crisis (e.g., COVID-19), order of any court or jurisdiction, event cancellation, scheduling conflict, inclement weather, or other cause not reasonably within Sponsor's control (each a "Force Majeure" event or occurrence), then Sponsor shall have the right to modify, suspend, or terminate this Sweepstakes. If this Sweepstakes is terminated before the end of the Promotion Period, Sponsor will (if possible) select the potential winner in a random drawing from all eligible, non-suspect entries received as of the date of the event giving rise to the termination. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances. If the Sponsor determines that all or a portion of the prize is unavailable or unable to take place as planned for any reason, including due to a Force Majeure event, then Sponsor reserves the right to substitute a prize or portion thereof with one of equal or greater value, and no other additional compensation or substitution will be provided.

13. ARBITRATION | Except where prohibited by law, as a condition of participating in this Sweepstakes, entrant agrees that (i) any and all disputes and causes of action arising out of or connected with this Sweepstakes, or prize awarded, shall be resolved individually, without resort to any form of class action, and exclusively by final and binding arbitration under the rules of the American Arbitration Association and held at the AAA regional office nearest the entrant; (ii) the Federal Arbitration Act shall govern the interpretation, enforcement and all proceedings at such arbitration; and (iii) judgment upon such arbitration award may be entered in any court having jurisdiction. Under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental or consequential damages, or any other damages, whether direct or indirect, as well as attorney fees, and entrant further waives all rights to have damages multiplied or increased.
